Space reservations are on a first-come, first-serve basis. No electrical hook-ups will be available. Vendor space is limited and pre-registration is required.

This is an outdoor event in early November. We hope for great weather but there is no guarantee. Please come prepared to protect your merchandise. Canopies are allowed.

Vendor set up on Saturday and Sunday from 8 - 10 a.m. Vendor sales may take place only within the vendor area. Do not leave your merchandise unattended at night. Security is not guaranteed.

All trash must be collected for proper disposal. Vendors must leave their area clean and neat.

No SWAT team or ammo dealers.

Space will not be guaranteed until payment is received. A forfeit of payment will occur for no shows. Cancellations must be made by October 15, 2011 for a full refund.
